"Training Course on Constitution Building for Democracy"

in cooperation of the Internaional IDEA and NAM CSSTC

I. Introduction

Constitutions do much more than establish government and regulate its relationship to citizens – for many states, they have become tools to manage crisis and conflict, build inclusive democracies and lay the foundation for a culture of human rights. Constitution building is a political process aimed at addressing the challenges that modern democracies are facing.

Constitutional reform has thus become a characteristic part of intrastate conflict resolution, peace building, democratic reform and equitable economic development. National stakeholders across many sectors must have a competent understanding of the process of constitution building, the challenges and constraints during these processes as well as the realistic opportunities for political and social transformation. This course will address what kind of practices will help citizens, leaders and their supporters build democratic, sustainable constitutions.

The International Institute for Democracy and Electoral Assistance (International IDEA) the Non-Aligned Movement Centre for South-South Technical Cooperation (NAM-CSSTC) are collaborating to offer a capacity-building training course on 'Constitution Building for Democracy' for practitioners for participants from ASEAN member countries, Chile, Cuba, South Africa and Timor Leste.

II. Overview

This five day course on *Constitution building for democracy* is aimed at professionals interested in developing their knowledge on the different stages and features of constitution building processes, and how constitution building practices influence the protection of political and other rights and liberties as a means to building democracies that resolve conflicts peacefully. The workshop will follow an experience-based and interactive learning format.

The workshop will revolve around norms, comparative practices and problem solving supported by resource materials from Constitution Building Training Programme:

- Module on constitution building practices and mechanisms
- Module on constitution building for a human rights culture

- o Improve their understanding of and engagement in constitution building processes
- o Be able to identify viable constitution building practices that are suited in their own contexts
- o Have broader options on how to bridge divisions on human rights issues


